#### 5. SPACE & FACILITIES

- 5.1 Bare Space (Minimum Booking 36sq. mtrs.)  
General facilities Bare Space include general Security, general decoration in and around exhibition halls, signage, general illumination inside and outside halls, cleaning of aisles and exterior, general publicity for visitors, poromotion and complimentary one copy of Expo Directory, business centre facilities (payment basis)
- 5.2 Shell Scheme Stalls-area as per layout (minimum booking 9 Sq. mtr.)
  - 5.2.1 Package of Facilities for shell Scheme stalls include back and side partitions with modern prefabricated system, carpet, fascia in English with stall number written in uniform style, three spot light, one 15/5 amp socket per stall, one dust bin, one laminated table & two chair for every 9 sq. mtrs. area, electricity consumption for lighting, general security in Exhibition Halls, general decoration in and around halls, general publicity for visitor promotion and complimentary one copy of the exhibition catalogue.
- 5.3 Participation Charges indicated on the application form (on reverse)

#### 6. SPACE ALLOTMENT

Allotment of space will be on "First Come First Served Basis". Stall/area will be Allotted with confirmed booking & initial payment, Possession of the stall/Space will be handed over on receipt of the full dues.

#### 7. CHARGES FOR SERVICES

The Charge for additional services (additional electricity for builtup stalls and bare space, 3 phase power load for demonstration of machinery and water connection etc.) will be extra. The Technical Manual will be sent to the exhibitor after their registration.

#### 8. EXHIBITION CATALOGUE

The Organizers will publish Exhibition catalogue and all the exhibitors get a free entry in the catalogue covering name and address of exhibitor, name of chief Executive, telephone, fax, area of specialisation, exhibits displayed and company profile not exceeding 100 words.

#### 9. TERMS OF PAYMENT

- 9.5 Discount is adjustable only in the last installment of payment.
  - 9.6 Service Tax as application along with the payment.

#### 10. NON ALLOCATION, CANCELLATION, NON PARTICIPATION

- 10.1 if the Organizers reject an application and do not allot space payment made by the prospective Exhibitor is refunded.
- 10.2 if the Exhibitor cancels participation before June 30, 2016 25% of the participation charges are adjusted and balance returned to party.
- 10.3 if the Exhibitor withdraws or cancels participation by JULY 30, 2016 50% of the charges will be forfeited.
- 10.4 if the Exhibitor cancels his participation after July 31 2016 full participation charges will be forfeited.
- 10.5 if the Exhibitor fails to turn up for setting up the stall or cancels his participation at the last minutes, Organisers shall utilize the space/stall in any manner they deem fit and all the money paid by due form the party shall stand forfeited/ recovered.
- 10.6 Other Service Charges once paid are not refundable in any case.
- 10.7 In case of shortfall of payment of dues by the party who confirm participation, the party shall be liable to pay the amount due to the organisers.

#### 11. CO-EXHIBITORS AND SUBLETING

Subletting of stall is prohibited Exhibitors may however share stall with Co-Exhibitors only after obtaining written permission.  
permission from organizer. National sector Exhibitors are not allowed to share stall with their overseas principals/coilaborators and not register overseas Exhibitors as their Co-exhibitors. They can join their overseas principals as co-exhibitors on payment of prescribed registration charges to the Organizers.

#### 12. TECHNICAL GUIDELINES

Exhibitors with bare space are to submit design of the stall to organizers and obtain approval for the plans in writing 3 copies of the plans with front & side elevations. special features of the display & electrical plan etc. to be submitted 3 months before the date of IIF 2016 and one copy will be returned to the Exhibitors bearing "Plan Approved" by the organization. Exhibitors are required to comply with instructions issued by organizers regarding schedule for setting up and dismantling stalls. Failure to comply with the instruction will attract rental charged by Exhibitors are liable to pay the penal rental.

#### 13. OVERALL HEIGHTS OF DISPLAY

Normal heights of stands shall be 2.50 mtrs. if Exhibitors are particulars of heights more than 2.50 mtrs. written permission of organizers may be obtained after submitting appropriate plans. Heights of display Stand in the central areas of the Exhibitors hall/island locations may be restricted to 1.50 mts so that a clear overall view of the display in the hall is available for the visitors to the hall(s).

#### 14. GENERAL

The Exhibitors are liable for physical harm to persons (Staff/agents/Organizers and other Exhibitors/ Visitors) and Damage to property of JECC/Organizers and other Exhibitors caused by himself or his agents during transportation, installation, fair duration and dismantling periods.

#### 15. RIGHT OF ORGANIZERS

To reject any application for space without assigning any reason. To amend the terms and condition of participation and issue additional Rules and Regulations for the Exhibitions from time to time which shall be binding on the Exhibitions. To Recover from the exhibitor any amount remaining unpaid. To recover from the Exhibitors. compensation for losses/ damages caused to the property or reasonable penalty for any willful contravention of these condition of participation.

To, postpone, curtail, extend or abandon the exhibition or change the venue of Exhibition, or change the allotment of space/stall or close some or all sections of its temporarily or permanently if unforeseen circumstances so require. In suce circumstance, the Exhibitors shall not be entitled to withdraw from the contract or to claim any compension or damage.  
To take photographs or video film of the interior of any stall and to use the same for promotional work.

To refuse permission to any Exhibitors to clear his stall if he has not discharged all dues to the organizers or to retain Exhibits of other goods as collateral security till dues are paid.

#### 16. SUPERVISED CUSTOMS CLEARANCE FOR OVERSEAS EXHIBITORS

Exhibits of approved overseas Exhibitors can be temporally cleared throught Indian customs without payment of customs duty against any of three instruments.  
ATA Carnet of Embassy Guarantees or Bank Guarantee.  
The clearnece will be subject to re-export within a period of six monts from the date of import.

The Official Handling and clearing Agency of the organizers are well versed with the procedures and can help the exhibitors in obtaining the clearance. The agency via their international network will contact the Exhibitors and plan the dispatches and advise about the Customs requirement and shipments.

The agency can also provide storge facilities for exhibits arriving prior to the opening of the show and simily after the show and this facility are available to those exhibitors who wish to hold their goods till they are able to close the sales with the prospective buyers with the approval of Customs authorize.

Sale of imported goods can be done only through official handling & Clearing Agents. approved by the Organizers and also Indian Custom Authorize.

#### 17. INSURANCE

Organizers shall not be responsible for any loss waightsoever incurred by Exhibitors and they should obtain insurance coverage for their exhibitors & Personal against all risks and for the periods covering preparations, setting up, currency and dismantling and return transit.

#### 18. COUNTER SALES

Counter sales are not permitted at the Exhibition. However Exhibitors can dispose of their exhibits equipment after exhibition is over. In case of sales tax of other applicale taxes or other applicable taxes as per order/ Rules of the Govt. Rajasthan/ Other Authorizes concered will be the direct responsibility of the exhibitors.

#### 19. FORCE MAJEURE

Under the condition of the force majeure which also include strike, lock out, closures, riots, the organizations reserve the right to alter the opening dates and duration or even the cancel the entire Exhibition. In case of changes in date and duration duration of IIF 2016 the contractual obligation between the Exhibitors and the Organizers remain infactced. In case of cancellation of the Exhibition the stall charges will be refunded to the Exhibitors after deduction the proportionate costs already incurred by the Organizers.

#### 20. ARBITRATION

All Disputes arising in connections with this Agreement shall be finally settled by a sole Arbitrator, to be appointed by the organizers under the provisions of Indian Arbitration and concillation Act. 1996.

#### 21. JURISDICTION

Only the courts in JAIPUR shall have jurisdiction.
